

### 'HMS Pinafore' Synopsis

We discover the H.M.S. Pinafore at anchor off Portsmouth with the crew going about their day-to-day chores. The local 'bumboat woman', Mrs Cripps (affectionalely known as 'Little Buttercup') arrives to sell her wares but what's the dark secret she's hiding? One of the ship's crew, Ralph Rackstraw, is madly in love with the Captain's daughter, Josephine; the sailors (excepting Dick Deadeye, the grim and ugly realist of the crew) offer their sympathies, but there's not much hope his love will ever be returned.

The Captain addresses his crew and reminds them how good a captain he is; he later confesses to Little Buttercup that his daughter, Josephine, is reluctant to consider a marriage proposal from Sir Joseph Porter, the First Lord of the Admiralty. Buttercup admits that she too knows how it feels to love in vain. Enter Josephine who reveals to her father that she loves a humble sailor in his crew; how will he react to that?

Sir Joseph and his "admiring crowd of sisters, cousins and aunts" arrive on deck and he explains how he became the "ruler of the Queen's Navee". He then proceeds to give the Captain a lesson in etiquette and insists that "a British sailor is any man's equal" — excepting Sir Joseph's. Shortly afterwards, elated by Sir Joseph's views on equality, Ralph decides that he will declare his love to Josephine and does so. Josephine is touched, but although she has found Sir Joseph's attentions nauseating, she knows that it is her duty to marry Sir Joseph instead of Ralph. Disguising her true feelings, she "haughtily rejects" Ralph.

Ralph is distraught and means to commit suicide; the crew expresses sympathy, except for Dick, who provides a stark counterpoint of dissent. Ralph puts a pistol to his head, but as he is about to pull the trigger, Josephine enters, admitting that she loves him after all. Ralph and Josephine make plans to elope that night.

Later that night, under a full moon, Captain Corcoran reviews his concerns and Little Buttercup offers him sympathy. He tells her that, if it were not for the difference in their social standing, he would have returned her affection. She prophesies that things are not all as they seem and that "a change" is in store for him.

Sir Joseph complains that Josephine has not yet agreed to many him. The Captain speculates that she is probably dazzled by his "exalled rank" and that if Sir Joseph can persuade her that "love levels all ranks", she will accept his proposal. They withdraw as Josephine enters, still feeling guilty about her planned elopement with Ralph and fearful of giving up a life of luxury. When Sir Joseph then makes the argument that "love levels all ranks", a delighted Josephine is now more determined than ever to marry Ralph.

Dick Deadeye tells the Captain of the lovers' plans to elope who then confronts Ralph and Josephine as they try to leave the ship. The pair declare their love, justifying their actions because "He is an Englishman!" The furious Captain is unmoved and blurts out, "Why, damme, it's too bad!" Sir Joseph and his relatives, who have overheard this oath, are shocked to hear swearing on board a ship, and Sir Joseph orders the Captain confined to his cabin.

Sir Joseph, furious at discovering Ralph and Joesphine's love for each other, has the sailor "loaded with chains" and taken to the ship's dungeon. Little Buttercup chooses this moment to reveal her long-held secret. Many years ago, when she "practised baby-farming", she had cared for two babies, one low-born, one high-born. She confesses that she "mixed those children up".

Sir Joseph now realises that Ralph should have been the Captain, and the Captain should have been Ralph. They appear, wearing each other's uniforms: Ralph as Captain, in command of the *Pinafore*, and Corcoran as a common sailor. Sir Joseph decides that, although "love levels all ranks", it does not level them enough for him to marry the daughter of a mere sailor so he gives Captain Rackstraw his blessing to take Josephine as his wife. The former Captain's now-humble social rank leaves him free to marry Buttercup. Sir Joseph, left alone, decides to settle for his cousin, Hebe; the crew and Sir Joseph's relatives rejoice at the news, as "three happy pairs" are united.

### 'Trial by Jury' Synopsis



The curtain rises on the Court of the Exchequer where a jury and the public assemble to hear a case of breach of promise of marriage.

The Usher introduces the proceedings by exhorting the jury to listen to the broken-hearted Plaintiffs case but telling them that they "needn't mind" what the "ruffianly defendant" has to say. The Defendant (Edwin) arrives, and the jurymen greet him with hostility, even though, as he points out, they have as yet no idea of the merits of his case. He tells them, with surprising candour, that he jilted the Plaintiff because she became a "bore intense" to him, and he then quickly took up with another woman. The jurymen recall their own wayward youth, but they are now respectable gentlemen and no longer have any sympathy for the Defendant.

The Judge enters with great pomp and describes how he rose to his position - by courting a rich attorney's "elderly, ugly daughter". The rich attorney then aided his prospective son-in-law's legal career until "at length I became as rich as the Gurneys" and "threw over" the daughter. The jury and public are delighted with the judge, and ignore that he has just admitted to the same wrong of which the Defendant is accused.

The jury is then swom in, and the Plaintiff (Angelina) is summoned. She is preceded into the courtroom by her bridesmaids, one of whom catches the eye of the judge. However, when Angelina herself arrives, she instantly captures the heart of both Judge and Jury. The Counsel for the Plaintiff makes a moving speech detailing Edwin's betrayal. Angelina feigns distress and staggers, first into the arms of the Foreman of the Jury, and then of the Judge. Edwin counters, explaining that his change of heart is only natural.

He offers to marry both the Plaintiff and his new love, if that would satisfy everyone. The Judge at first finds this "a reasonable proposition", but the Counsel argues that from the days of James II, it has been "a rather serious crime to marry two wives at a time" (humorously, he labels the crime in question "burglary" rather than "bigamy"). Perplexed, everyone in court ponders the "nice dilemma" in a parody of Italian opera ensembles.

Angelina bemoans her loss in evidence of the large amount of damages that the Jury should force Edwin to pay. Edwin, in turn, says he is a smoker, a drunkard, and a bully (when tipsy), and that the Plaintiff could not have endured him even for a day; thus the damages should be small. The Judge suggests making Edwin tipsy to see if he would really "thrash and kick" Angelina, but everyone else (except Edwin) objects to this experiment. Impatient at the lack of progress, the Judge resolves the case by offering to marry Angelina himself. This is found quite satisfactory, and the opera is concluded with "joy unbounded".





'HMS Pinafore'







This year, New Rosemere was saddened to lose 3 stalwarts of the Society. These three men represented all areas of the Society between them — committee, stage, crew and orchestra.

#### **Geoff Orrell**

A member of Rosemere since 1977, Geoff made 31 appearances in the tenor chorus.

As well as his regular appearances on-stage, Geoff served on the Committee, taking on several roles, including that of Honorary Treasurer for a total of 10 years between 1977 and 1991, then as Vice Chairman, Acting Chairman and Chairman for a total of 8 years between 1985 and 2001. After stepping down from the Committee, Geoff continued to be a huge support to the Committee and the Society as a whole; often to be found, in later years, helping front of house at our annual productions.

#### **Jack Lowe**

Jack came to Rosemere as a result of the love of his life, Mona (nee Richardson) being a leading soprano in the Society and bringing him along. Jack's most important role for Rosemere began in 1990 when he became one of the 'Scenery Staff', this role would continue until the turn of the Century. Over those years, Jack took a leading role in scenery construction and design, many of these sets gaining critical acclaim and even winning Best Set Design and Costumes in 2004. Jack stepped down as 'Master Carpenter' in 2007 and reverted to his original role of 'Stage Crewman' which he continued doing until 2012. Jack was never afraid to speak his mind but was a sincere and sturdy support to the Committee and Society over the years.

#### **Andrew Morley**

Andrew played the violin in Rosemere's orchestra for many years. A well-loved player and an all-round good bloke; Andrew was always very supportive of the Society, posting flyers through doors as he travelled to the theatre up-to and during show week and staying to help take down the set and tiering at the end of the show week.
